In the field of merger & acquisition, the notable cases Mr. Zhang led include the China's very first case in which a red chip Hong Kong listed public company (Skyworth Digital) spins off part of its China business to list in A share market through reverse merger, acquisition of majority shares of YangGuang (A share stock code: 000608) by a consortium led by ICBC (representing the consortium), acquisition of Greater China business of Karl Lagerfeld by Septwolves (representing Septwolves), acquisition of Target Media and CGEN media by Focus Media (representing Focus Media), acquisition of Leysen (a Belgium jeweler) by Tesiro (A share stock code: 603900).
